2	Renunciation of Indian Nationality	The Indian Citizenship Act, 1955 does not allow dual citizenship. Holding an Indian passport / acquiring an Indian passport / travelling on an Indian passport after acquisition of foreign citizenship constitutes an offence under the Indian Passport Act, 1967, and attracts penalties. Indian nationals, who have already obtained citizenship of another countries must renounce/ surrender their Indian passport immediately after acquisition of foreign citizenship. 		All the persons of India origin, who have acquired foreign nationality on or before 31.05.2010 must surrender their Indian passport. They will be issued 'Surrender Certificate' and cancelled Indian Passport. All the persons of Indian origin, who have acquired foreign nationality on or after 01.06.2010, must surrender their Indian Passport and Renounce Indian citizenship. for a Surrender Certificate and Renunciation of Indian before 1st nationality. Applicant should also submit self-declaration as June, 2010 per Annexure I along with their renunciation application.

All the persons of Indian origin, who are unable to produce Indian passport should apply for a sworn affidavit stating the reasons for not being able to produce the Indian Passport. Along with Sworn affidavit they should also apply for renunciation of Indian nationality. Applicant should also submit self-declaration as per Annexure I along with their renunciation application. Sworn affidavit, signed declaration and Renunciation certificate will be given back to the applicant.

Please note that date on the Naturalization Certificate will be treated as date of acquiring foreign nationality and not from the date the Portuguese/foreign passport was issued. The date of publication must therefore be mentioned on the Naturalisation Certificate.

The applicant would fill his/her details online and upload the relevant documents on the online portal of MHA viz. https://indiancitizenshiponline.nic.in/. The applicant has to pay fee in the Embassy with the printout of online application as prescribed in Schedule IV of the Citizenship Rules 2009.

The applicant would take print-out of his online application and visit the Embassy for interview, signing the declaration and to submit the printout of the application with following documents.

- 1.Original Indian passport along with Passport Copy (first page and last page)
- 2.Portuguese Passport copy
- 3.Portuguese Birth Certificate copy (all three pages) with endorsement stamp of date of acquisition of Portuguese Nationality.
- 4. Applicants needs to fill the application for Renunciation of Indian nationality through the following link https://indiancitizenshiponline.nic.in/
- 5. Applicants also needs to fill the application for surrender of

		Indian Passport through the following link — ttps://portal3.passportindia.gov.in/Online/index.html 6.A person who has ceased to be Indian citizen is required to surrender the documents which he/she had acquired on the basis of his Indian Citizenship (e.g. Voter ID Card, Aadhar etc.) to be authorities concerned. The minimum prescribed time for the procedure of Renunciation of Citizenship and surrender of Passport, is eight weeks, after receipt of the duly completed application in the Embassy.
