### Visa Invitation Letter

MPEDA will provide Visa invitation letter to the importers to apply for visa.



### Air Fare Reimbursement

Reimburse the return economy air ticket fare with a ceiling of 2,000 US\$.  
(Limited to 1 representative /company)

The reimbursement will be in cash on the spot at the venue directly to the importers on the last day of the event upon production of copy of visa, air ticket, invoice and boarding pass.



### Airport Pick-up and Drop

We will operate a reception counter at Chennai International Airport to arrange airport pickup / drop for the invited importers.



### Local Hospitality

We will be providing the local hospitality to all the invited importers (Food, accommodation and local transportation during the event days). Also arrange net working dinner with exporters.



### Support to Visit Seafood Processing Plants

We will facilitate local travel arrangements for seafood processing plant visits through our Regional Offices.

The importer needs to bear the expenses related to his travel from Chennai International airport and back (air / train / car) and hotel accommodation.

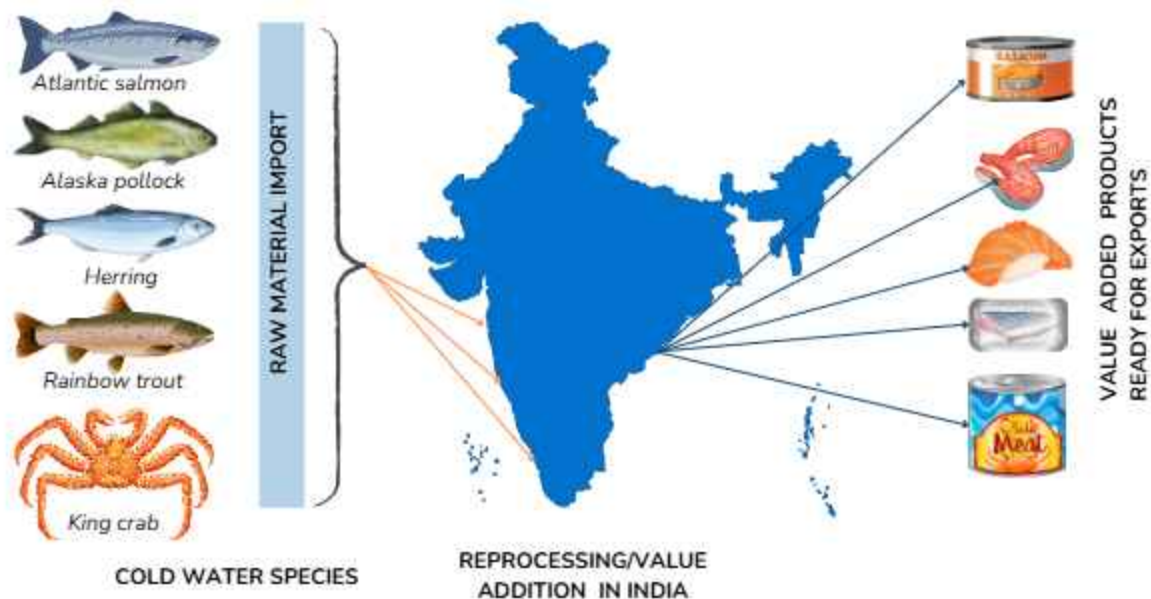

# INDIA-A SEAFOOD PROCESSING & RE-EXPORT HUB

## Why India !!

- India with its world class infrastructure, strategic geolocation and abundant manpower, shall be able to perform seafood-based jobs outsourced to our country for import, value addition and re-export.
- India's seafood processing capacity is about 35,000 Tons/Day and the total capacity utilization is around 30 % -35 % only.
- Labour cost in India is cheaper and competitive when compare with labour cost in developed countries viz. USA, EU etc.
- With state of art processing facilities and competitive labour cost, India can act as a processing hub for re-processing, value addition and re-export in line with China, Vietnam, Malaysia, Thailand and Indonesia.



## Support from us

- MPEDA will facilitate ease of doing business for processing and re-export seafood in value added form.
- MPEDA will facilitate in identifying potential qualified processors to take up processing works and re-export in to required destinations and to make India as a seafood processing hub.
- MPEDA will also facilitate in identifying joint venture partner for processing with buyer back arrangements. Presently more than 12 such joint venture projects are in operation for pasteurized crab meat for USA and cephalopod products into EU countries.
